The undersigned agrees to be fully responsible for the charter of Blue Sky Limousine’s vehicle/vehicles as stated above and assumes full financial responsibility for any damage to any vehicle or any property caused by the occupants whether by accident, neglect or intent. The undersigned agrees to be responsible for any additional charges not included in the rental charge (i.e. overtime, downtime, parking, tolls, incidentals, deadhead or damages.) The undersigned agrees to be bound by the following terms and conditions.

- The deposit is non-refundable.
- A “no show” will be charged at the full rental rate.
- There is no smoking in the vehicles.
- Blue Sky Limousine and it’s representatives and/or driver(s) assume no responsibility for any articles left in the vehicle at any time.
- Blue Sky Limousine and it’s representatives and/or driver(s) assume no responsibility for any acts, illegal or otherwise, of the occupants.
- Blue Sky Limousine reserves the right to refuse service.
- The driver of the said limousine may terminate the charter without refund should he/she deem the occupant(s) unruly or violating safe operation of the vehicle.
- Blue Sky Limousine will not be held responsible for delays or inconveniences due to traffic, unknown/unseen mechanical failures or situations deemed on “Act of God”.
- Any chauffeur gratuity (recommended 10 -15%) is in addition to the basic rental charges.
- Extra time will be charged directly to the credit card below at \$125.00/hour (minimum 1 hour charge will apply)

Costs for damages are as follows:

- (a) broken decanter \$ 50.00
- (b) broken glassware \$ 10.00
- (c) spills \$ 35.00
- (d) cigarette burns or smears \$ 350.00
- (e) oesophageal expulsion \$ 300.00

The above stated damages are minimum amounts. For these, or any other damages, the undersigned agrees to pay the cost of the damages/replacement plus downtime charges of \$500.00 per day.

In the event the terms and conditions stated herein are not complied with, the undersigned hereby authorizes Blue Sky Limousine to apply charges to the undernoted credit card.
